Hand protection

Chemical-resistant, impervious gloves complying with an approved standard should be worn if a risk assessment indicates skin contact is possible. It is recommended that gloves are made of the following material: Nitrile rubber; thickness 0.35mm minimum. Butyl Rubber; thickness 0.5mm minimum. PVC; thickness 0.5mm minimum. Fluorinated rubber (Viton); thickness 0.4mm minimum. The breakthrough time for any glove material may be different for different glove manufacturers. Glove thickness is not necessarily a good measure of glove resistance as the permeation rate will depend on the exact glove composition. Considering the data specified by the glove manufacturer, check during use that the gloves are retaining their protective properties and change them as soon as any deterioration is detected.
